EXISTING BUILDING AND SITE: The property is currently being utilized as a 94-unit 3-story TownPlace Suites Hotel, comprising 53,032 SF located on 2.96 Acres. The buildings were originally built in 1999 with a full renovation completed in 2015 which included all guestrooms, public areas, and exterior spaces.

LOCATION: Mount Laurel is a township in Burlington County, New Jersey and is considered part of the Philadelphia MSA. Mount Laurel Township is approximately 22 square miles, suburban in nature, with approximately 41,000 residents. Most of the residential housing is single-family homes, town houses and condominiums. Burlington County is the largest in New Jersey by area, and its county seat is Mount Holly Township.

ADAPTIVE REUSE: Tapestry Mount Laurel consists of two four-story buildings currently operating as a Town Place Suites Hotel that is proposed as an adaptive reuse to market rate, multifamily housing. The adaptive reuse of an existing building is comprised of both renovated units in conjunction with new construction. The two buildings will be connected to create additional common space. Common space amenities are comprised of spaces created for common amenities.

PROPERTY MANAGER: Crown Equities, LLC is a national owner, developer, and manager of senior and multifamily housing. The company is located in Minneapolis, MN with facilities throughout the country.

UTILITIES, OPERATING COSTS, ENERGY EFFICIENCY AND SOLAR: All utilities, internet, cable, or satellite are tenant paid. Crown will install a solar energy system on new construction roofs and meet certifications of the National Green Building Standards (NGBS) for increased energy efficiency, water reductions, indoor air quality and building operations.


